Notes on Gift Aid:

1. You must pay an amount of income tax and/or capital gains tax at least equal to the tax that CVRPS reclaims on your membership subscriptions and donation in the tax year (currently 28p for each £1 you give).
2. CVRPS will treat all your membership subscription and donations that you have made since 6 April 2000, and all made from the date of this declaration, until you notify us otherwise, as Gift Aid donations. You can cancel this declaration at any time by notifying the membership secretary.
3. If in the future your circumstances change and you no longer pay tax on your income and capital gains equal to the tax that CVRPS reclaims, you can cancel your declaration (see note 1).
4. If you pay tax at a higher rate you can claim further tax relief in your Self Assessment tax return.
5. Please notify the membership secretary if you change your name or address.

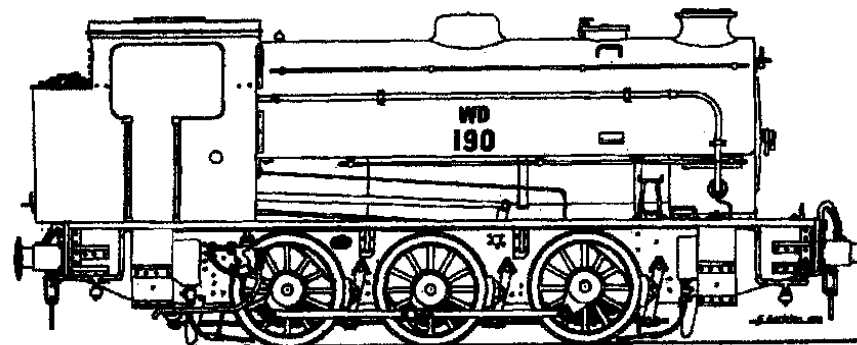
